





Adult Supervision Population-8130









Transitional Age Youth (TAY) Supervised Population-1134

Probation Youth Represent .47% of Countywide Youth Population


- 120,550 Youth Aged 12 17 Countywide





Juveniles in Facilities by Race and Gender (n=61)



Youth in Detention Alternatives by City of Residence*









Juvenile Probationers by City of Residence*





Juveniles in Intake / Investigations by City of Residence*












DJJ Commitment Rate in California Counties 2019


- This chart represents DJJ commitment rates for counties in 2019.

- Alameda had a no commitments to DJJ in 2019, while the statewide average was 11.2.
- The 2019 DJJ commitment rate represents the number of youth committed by a county's courts to a state detention facility during 2019 per 100,000 juveniles aged 12 -17 in the county.



Youth in Group Home Placements and Juvenile Facilities, 2013 – 2019





Number of Direct Files and Commitments to Department of Juvenile Justice (DJJ) Facilities by Year, 2014 - 2019






Juvenile Hall Occupancy Rates in Alameda County and Statewide, 2008 - 2019




