

The Delinquency Prevention Network (DPN) is a collaborative group of agencies that provide prevention services to youth in Alameda County who are system-involved, or at risk of becoming system-involved. Common reasons for referral include habitual truancy, running away from home, trouble with law enforcement, engaging in high-risk behaviors, and being beyond parental control.

Youth are referred by a variety of Alameda County sources, including, but not limited to the following:


