#### What did you present to OYCR?

Please see the attached Plan Addendum.

 ACPD originally projected 5 youth per year based on past DJJ data. There are currently 14-15 youth at JJC that are in for serious offenses. Youth are also returning sooner from DJJ. Our projections have been updated.

#### How many staff bid into the unit?

Six staff bid into unit 3.

#### Is school in-person right now?

School has been in-person since July.

How is Behavioral Health prioritizing staffing for the school? Behavioral Health is actively recruiting.

# 5. Status of SB 823 Implementation

- Yasmin Burke Taylor is the Division Director over SB 823
- Youth have a variety of programs including:
  - o ROP
  - o Family Spring
  - Dragon Slayer
  - Growth
  - In-person yoga and mindfulness
  - Hope and Wellness
  - 6 youth enrolled in Laney classes
  - Other youth in high school
  - 3 youth set to graduate next month; also in dual enrollment and taking college classes
  - One youth enrolled in a parenting program and electrician training which is starting in July
  - Other leisure activities including gym, blacktop, etc.

#### How often do the youth get out to the blacktop?

Currently two times a week; trying to increase to three. Twelve new Probation staff returning from training, so more staff will be available. Also, ACOE will take youth out to the blacktop for PE

#### Can youth get to the blacktop every day?

That's our goal. We are working on it.

#### What is the engagement rate?

Most youth participate in programs. When youth choose not to participate they are given a choice to do something different.

#### Have staffing issues impacted programming?

No

# Have there been any conversations with the youth regarding what programs they would like to see?

The youth have provided us with their thoughts regarding what they think is missing, such as learning about real estate, stock market, financial planning, etc. Probation will look into implementing some of the ideas.

#### Is the youth's schedule finalized? Can it be shared?

Yes. The schedule was emailed to the group for review.

A request was made to distribute a flyer regarding the June 22 event.

# Is Probation meeting the minimum standard of having the youth out one hour per day? When the staffing issues are addressed, will Probation meet the minimum?

Probation is meeting large muscle exercise requirement and youth are outside for a minimum of one hour per day. There is outdoor space attached to all housing units. Probation is not required to take youth to the blacktop, however that is the goal.

#### What type of activities take place in the outdoor space?

It can be used for group or one-on-one activities. The school uses that space as well. Youth can also use the gym for exercise. They do get out quite a bit.

#### Is ACOE doing PE? Does Unit 3 go to the gym?

Unit 3 goes to the gym twice a week. Probation staff also take youth out to the gym as schedule permits.

#### **Facilities Update**

 Met with Greater New Beginnings to explore possibility of stepdown options for SB 823 youth. The leadership was not willing to accept this population into their program.

#### Can Camp be secured to use as a step-down option?

Probation will be presenting to the Public Protection Committee in their July meeting supporting the fencing. It would be up to the Court to decide whether Camp can be used as a step-down option.

#### What are the current step-down options?

The legislation does not define what a step-down is. We need to continue this conversation.

# How soon will there be a youth that is ready for a step-down?

The court believes this could be as early as January.
