SUBJECT: ADOPT A RESOLUTION FOR THE JUVENILE JUSTICE COORDINATING COUNCIL AND SUBCOMMITTEE MEMBERS

Dear Board Members:

RECOMMENDATIONS:

Adopt a Resolution in compliance with Welfare and Institution Code 749.22 and Senate Bill 823 to:

- A. Affirm and appoint the Juvenile Justice Coordinating Council members as listed in Attachment A; and
- B. Affirm and appoint the Juvenile Justice Coordinating Council Senate Bill 823 Subcommittee members as listed in Attachment B.

DISCUSSION/SUMMARY:

Welfare and Institution Code 749.22, (established 9/15/98) requires each county to establish a Juvenile Justice Coordinating Council (JJCC) that shall develop and implement a continuum of county-based responses to juvenile crime. The coordinating council shall, at a minimum, include the chief probation officer as chair, and one representative each from the district attorney's office, the public defender's office, the sheriff's department, the board of supervisors, the department of social services, the department of mental health, a community-based drug and alcohol program, a city police department, the county office of education or a school district, and an at-large community representative.

According to 1995(a) of the Welfare and Institution Code, a county shall create a subcommittee of the JJCC to develop a plan describing the facilities, programs, placements, services, supervision, and re-entry strategies that are needed to provide appropriate rehabilitation and supervision for realigned youth from the Division of Juvenile Justice (DJJ) to be eligible for funding.

On February 9, 2021, the Alameda County Board of Supervisors approved and appointed the members of the JJCC and the SB 823 Subcommittee. According to the established by-laws, each non-permanent member serves a term limit of (2) years, and said terms expired at the end of February 2023. Those seats which have expired on the JJCC include the at-large community member and the community based drug and alcohol program representative. On the SB 823 Subcommittee, all five (5) district seats, and the youth representative have expired.

On March 13, 2023, the JJCC convened for the sole purpose of taking action, for both the JJCC and the SB 823 Subcommittee, to submit recommendations to fill the non-permanent member vacancies. The submission of the resolution includes the voting membership's recommendations.

Alameda County Probation Department (ACPD) does recognize the continued vacancy which exists on the SB 823 Subcommittee to serve as the District 1 representative, and has committed to the continued acceptance of applications until a member has been identified to fill the seat, at which time ACPD will be prepared to bring the matter back to the Board of Supervisors for affirmation and appointment.

FINANCING:

There is no cost associated with this Resolution, and there is no impact to net County cost.

VISION 2026 GOAL:

This request is in compliance with Welfare and Institution Code 749.22 and SB 823 and meets the 10X goal pathways of **Crime Free County** in support of the County's shared visions of a **Thriving and Resilient Population** and **Safe and Livable Communities**.
