### Question:

Is it anticipated that the youth would go outside weekly or more frequently?

It is built in the schedule. We take a poll. Most times there have been challenges with the youth being willing to go outside.

8. Safe Passages Presentation

Safe Passages presented an overview of the aftercare services provided to youth in the community.

#### Question:

About how many hours are usually spent with each youth weekly? About 5-10 hours but it can be more as needed.

#### **Question:**

What does a physical and mental health follow up look like? There are times when a youth is handed a phone number and are told they are expecting you and there's no follow up.

The relationship with the youth begins the final few months before they are released. There is warm handoff to resources.

### Question:

Have many of your staff been previously incarcerated or have lived experience?

We have multi-disciplinary staff. Some have gone through formal education, and some are lay life coaches with lived experience or have family members with lived experience within the criminal justice system.

- 9. Firm Roots Academy Update
- The phases in the Firm Roots program have been implemented which have helped with participation and behavior stabilization.
- Youth and staff participate in an Academic Advisory meeting every two weeks.

	<ul> <li>We are getting positive feedback and good participation levels with family engagement.</li> <li>The DMV initiative is helping youth obtain their Real IDs so they're more prepared to open a bank account.</li> <li>Youth participated in the Blue Water Sailing program where they learned about sailing mechanics. A second group is planned to participate.</li> <li>One youth was taken to a campus orientation at Sacramento State University where he will be taking classes online.</li> <li>There have been zero contraband incidents this quarter.</li> <li>The Roots Academy leadership will present at APPA in New York this month. This is a chance to share the progress of the SB823 program with the probation community and community corrections.</li> </ul>
