The survey was given out by the facilities staff. It was a paper copy, provided to each youth in an envelope. Confidentiality and informed consent protocols were followed. Qualitative data to be processed/provided at a later time.

Can we have more information on Family Engagement?

DNA plans to report further on the topics of Family Engagement and Peer Relations.

Please discuss how often youth are going outside, specifically to the blacktop. Is there any hard data?

Probation was keeping track of time youth spent outside before the construction began on the new recreation space.

- It was requested that Probation keep track of the expected time outside versus actual time outside in order to measure progress and add the data to the current report.
- Probation reports that youth get to the gym, play basketball or dodgeball 5-6 times per week.
- Page 49 details number of hours DSAL programs with the youth.
- Add a summary of this part of the presentation to the report, such as, "Probation previously kept track of youth's outdoor time but stopped during the construction of the recreational space and poor weather. Now that the construction is complete, youth use the space and probation commits to tracking outdoor time again." Highlight the equipment and the investment.
- Probation commits to identifying this as a priority, highlight the investment, and commits to 100% compliance.
- It was requested that a table be added to the report that lists the number of youth (population) in the unit by quarter.
- Add info on how many youth participated in the survey, i.e. 10 out of 11 FRA youth participated in the survey. One youth was not available, due to medical appointment.
- p. 29 Food Vendor paragraph will be removed and a new paragraph regarding the Recreational Area will be added.
- p. 31 Re-word the first sentence in paragraph "Culture of Collaborative Care".
- p. 32 Move the Behavior Management Point System paragraph to the Incentives section.
- p. 33 Add the Last Mile Classroom info.
- p. 42 Reword sentence that starts with "Ongoing updates".

What do you mean when you said there is an increase in staff-led programming?

The increased probation staff are not replacing CBO providers. They are supporting the milieu, providing structured programming when

youth self-select out of provider's program, and provide other skill development. For example, probation staff run the ART program.

How frequent are the MDTs?

There are mandatory MDTs and additional ones are scheduled as needed. There are also frequent Academic Advisory Meetings.

Are family members invited to MDTs?

Yes. This can be highlighted.

Is there a way to track how often families attend MDTs? Yes, probation has this information.

- There was a request to bold the # of Youth Stepped Down line on page 19.
- On p. 46, discuss the number of mental health clinicians assigned specifically to FRA in addition to numbers for all JJC, such as "BH is staffing up the Guidance Clinic to allow for a dedicated clinician for Firm Roots who will be able to support the milieu."
- p. 57 bottom under "Additional Consideration for TAY" add, "BH Department lifted up a TAY SFP". These are additional services for these youth after release, if needed.
- It was requested that Tables 12 & 13 reference each other using an asterisk.

What is Occupational Therapy Training Program?

Occupational Therapy (OTTP) teaches youth skill development through recreational activities.

Is there a section on family therapy?

Yes, please see p. 54.

What is the level of participation in these programs?

This is listed under the Areas of Growth section. Probation is transitioning service providers away from paper forms and to using the Enterprise case management system to track participation. Our goal is to provide this information at the next reporting period.

- There is a request that the level of participation is provided in this year's report.
- Probation will not be able to meet this request by May 1, but is committing to having this data available at the next reporting period.
- Minimum standards and tracking of family engagement can be worded, "family engagement will be offered." Some family engagement is not appropriate for all youth. Track engagement offered and participation.
