Risk & Needs Assessments

ACPD Currently Uses

- YLS/CMI
 - For youth in community supervision
 - Youth <18 years old
- COMPAS
 - Youth 18+
 - Used by CDCR

DJJ Currently Uses

- CA-YASI
 - For risk & needs
 - Also used to determine level of secure placement
 - Further specialized assessments if indicated
 - Special Education
 - Mental Health
 - Etc.



Background on YASI

- YASI = Youth Assessment & Screening Instrument
- Validated tool, higher accuracy for higher risk
- Gender responsive
 - Different "cut off" scores for girls & boys
- Domains:
 - Family
 - Aggression
 - Peers
 - Adaptive Skills
 - Family
 - Attitudes
 - Free Time
- Trained staff can administer

Background on PACT

- PACT = Positive Achievement Change Tool
 - Validated tool, heavily adapted from the YASI
 - Assesses strengths as well as risk/needs
 - Open Domains:
 - Criminal History
 - School
 - Use of Free Time
 - Employment
 - Relationships
 - Family

- Alcohol and Drugs
- Mental Health
- Attitudes/Behaviors
- Aggression
- Skills
- Living Arrangements
- Trained staff can administer
- M-PACT (modified) reduces weighting of criminal history, so better for RED
 - Also improves accuracy for girls



Also Using PACT

- Florida
- Washington State
- Delaware
- Wyoming
- Virginia
- NOTE: the PACT is much newer than the YASI



Risk & Needs Assessments

- Important considerations:
 - Staff training & regular refresher training essential
 - Perhaps the biggest issue re: assessments is inconsistencies in administration, application, & utilization
 - Many studies find they can't evaluate effectiveness of RNA tools because of large inconsistencies
 - Inter-rater reliability studies
 - To ensure administration & interpretation of tool is consistent



Risk & Needs Assessments

- Important considerations (cont.)
 - Internal RED analyses
 - To ensure tool is not leading to or exacerbating RED
 - Assessing risks & needs consistently for white and nonwhite racial/ethnic groups
 - Static domains are not too heavily weighted
 - Or scores will always stay high, regardless of change/improvement
 - Tools are used within a "risk-needs-responsivity" framework
 - ACPD already uses this framework



Current Programming & Model

- ACPD committed to the <u>Youth in Custody Practice Model</u>
 - Model developed by the Center for Juvenile Justice Reform & Georgetown University
 - Based on research & "what works" in the field
 - Have been participants since 2018
- YICPM offers evidence-based guidance on:
 - Case planning
 - Facility-based services
 - Transition/reentry
 - Community-based services



Current Programming & Model

- ACPD also participated in Georgetown University's <u>Reducing RED</u> program
 - Multi-disciplinary team, a holistic effort by the Probation Department
 - Participating Agencies:
 - Probation
 - Public Defender's Office
 - District Attorney's Office
 - Oakland Police Department
 - Juvenile Justice Delinquency Prevention Commission
 - Superior Court
 - Community Based Organization representation

Programming, Treatment, & Gaps

- Alameda County has already begun a long-term assessment of programming, ensuring they are incorporating best-practices
- Existing programming areas align with DJJ offerings
- Gaps:
 - Sex Offender Treatment
 - Severe Mental Health Needs
 - ACPD intends to enhance mental health treatment services in partnership with AC Behavioral Health
 - Gender-responsive programming (girls & sexual minority youth)
 - Alameda County is considering regional partnerships
